



Dear Property Owner,

The Simmons Bank Championship presented by Stephens will be played at Pleasant Valley Country Club Monday, October 21st to Sunday, October 27th. You are receiving this letter because your home has direct access to the PVCC property, which will be a secure area during the event.

All homes on the west side of Rodney Parham fall on the **RED HANGTAG** side of the PV POA neighborhood. You will need to use the hangtags enclosed with this letter to access your home. Please see below details about tournament week operations surrounding the PVCC property.

Red Hangtag Details:

- All property owners receive four weekly hangtags.
- These are needed to access your neighborhood between the hours of 7am – 7pm from Monday, October 21 to Sunday, October 27.
- LRPD will be monitoring all entrances to the neighborhood during these hours and only Official Tournament Shuttles/Vehicles or vehicles with RED RESIDENT hangtags will get through these check points.
- If you plan to have a large gathering, please notify your neighbors and plan accordingly for guest arrivals.
- **Have your RESIDENT hangtag on display (red side forward) at all times during Tournament Week to avoid any issues.**

Deliveries:

- Standard certified delivery services (including Amazon) will still have access to your home during those hours, but please plan to provide a hangtag to any other services (home cleaning, yard work, etc.) that will need to access your home during the week.
- Outside of the monitored hours, traffic will flow as normal through your neighborhood.

Road Closures:

- Valley Club Circle between Tam O’Shanter Court (starting at 449 Valley Club Circle) and Pebble Beach Dr. will be closed to all vehicle traffic from 7am – 7pm, Wednesday - Sunday.
- This is to protect PGA TOUR participants and spectators. Please plan accordingly when entering the neighborhood during those hours.
- Should you be attending the tournament, there will be a Tournament Walk-Up Entrance located near the intersection of Valley Club Circle and Pebble Beach Drive for your convenience. Walk-ups are also welcomed at the Main Entrance at the corner of Valley Club Circle and Pleasant Valley Drive. All spectators must have a ticket to access PVCC property.

Golf Carts:

- No personal golf carts will have access to the Pleasant Valley Country Club property during Tournament Week.
- If an unauthorized golf cart is spotted on the property, the driver is subject to arrest.
- There is no golf cart parking allowed at any entrances or along roadways.



Perimeter Fencing:

- There will be substantial fence added around the golf course along the Pleasant Valley Country Club property line.
- Please refrain from cutting, moving, or otherwise obstructing this fencing ... it is there to protect your property from the thousands of spectators that will be attending the Simmons Bank Championship.

Official Tournament Parking will be located in several areas near your neighborhood, including First Baptist Church, Pulaski Academy, and St. James Methodist Church. These are all private parking lots that require a tournament-issued parking pass and will be monitored throughout the week. There is no parking allowed in the green spaces or in residential yards anywhere in the PV POA boundary.

Should you have any issues with vehicles parked in your neighborhood without the appropriate hangtag, you can contact JHook Towing & Recovery at (501) 955-2400 for assistance.

Thank you for your patience while the Simmons Bank Championship team has worked with City Officials, Little Rock Police and the Pleasant Valley POA to develop a plan that protects both your property and your family during this exciting event. We hope you are excited about the PGA TOUR Champions coming to your neighborhood and we look forward to continuing to work with you for the next five years.
