



Dear Property Owner,

The Simmons Bank Championship presented by Stephens will be played at Pleasant Valley Country Club Monday, October 21<sup>st</sup> to Sunday, October 27<sup>th</sup>. You are receiving this letter because your home falls within the PV POA neighborhood in an area that will likely experience tournament-related disruptions.

All homes on the east side of Rodney Parham fall on the **YELLOW HANGTAG** side of the PV POA neighborhood. You will need to use the hangtags enclosed with this letter for any vehicles not parked in an enclosed garage/carport during tournament week. Please see below details about tournament week operations surrounding the PVCC property and parking in your neighborhood.

#### **Yellow Hangtag Details:**

- All property owners receive four weekly hangtags.
- These are needed to park in driveways and on the roadway in your neighborhood between the hours of 7am – 7pm from Monday, October 21 to Sunday, October 27.
- This is to prevent tournament spectator parking along your streets, in your driveways, or blocking neighborhood traffic. If you plan to have guests at your home or plan to have a large gathering, please communicate that with your neighbors to avoid vehicles being towed.
- Homeowners are not permitted to sell parking on their property, per the PV POA.
- The tournament will be placing “NO PARKING” signs throughout the neighborhood and along Pleasant Valley Drive.
- The tournament will not be enforcing parking on this side of Rodney Parham – that is left to the homeowners to enforce as you see fit. A preferred towing company is listed below should you need vehicles removed.
- **Have your RESIDENT hangtag on display (yellow side forward) when parking in your driveway or along the street during Tournament Week.**

#### **Deliveries:**

- Standard certified delivery services (including Amazon) will still have access to your home during those hours, but please plan to provide a hangtag to any other services (home cleaning, yard work, etc.) that will need to park at your home during the week.

#### **Tournament Access:**

- Should you be attending the tournament, walk-ups are welcomed at the Main Entrance at the corner of Valley Club Circle and Pleasant Valley Drive. LRPD will be managing the intersection of Rodney Parham and Pleasant Valley Drive to ensure pedestrian safety.

#### **Golf Carts:**

- No personal golf carts will have access to the Pleasant Valley Country Club property during Tournament Week.
- If an unauthorized golf cart is spotted on the property, the driver is subject to arrest.
- There is no golf cart parking allowed at any entrances or along roadways.

Official Tournament Parking will be located in several areas near your neighborhood, including First Baptist Church, Pulaski Academy, and St. James Methodist Church. These are all private parking lots that require a tournament-issued parking pass and will be monitored throughout the week. There is no parking allowed in the green spaces or in residential yards anywhere in the PV POA boundary.

**Should you have any issues with vehicles parked in your neighborhood without the appropriate hangtag, you can contact JHook Towing & Recovery at (501) 955-2400 for assistance.**

Thank you for your patience while the Simmons Bank Championship team has worked with City Officials, Little Rock Police and the Pleasant Valley POA to develop a plan that protects both your property and your family during this exciting event. We hope you are excited about the PGA TOUR Champions coming to your neighborhood and we look forward to continuing to work with you for the next five years.
